The Section Officer (Cash Section)/ Drawing and Disbursing Officer, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para 1 above for **Rs Rs.1,51,65,500/-(Rupees One Crore Fifty One Lakh Sixty Five Thousand and Five Hundred only)** and remit the same to **District Collector & Chairman, Child Labour Eradication Society, Ranga Reddy (A.P.)** through crossed demand draft under intimation to Child Labour Section.
