**Subject:** Grant-in-aid to **the District Collector & Chairman, Child Labour Project Society, Tiruchirapalli District, Tamil Nadu** for running of **30 Special Schools** and meeting the expenditure of Project Society –release of **1<sup>st</sup> instalment for the year 2007-08.**

Sir,

I am directed to convey the sanction of the President to the release of 1<sup>st</sup> instalment of grant-in-aid for the current financial year 2007-08 of **Gross Rs. 40,47,500/- (Rs. Forty Lakh Forty Seven Thousand & Five Hundred Only)** and **Net amount of Rs. 10,62,992/- (Rs. Ten Lakh Sixty Two Thousand Nine Hundred & Ninety Two Only)** (after adjusting unspent balance of Rs. 29,84,508/- as shown in the Quarterly Progress Report of March'07) (details at annexure) to the **District Collector & Chairman, Child Labour Project Society, Tiruchirapalli District, Tamil Nadu** to meet the expenditure of the Project Society and for running up of **30** special schools of 50 children each under the scheme of NCLP at an approved Budget of **Rs. 80,95,000/-**. **Utilization Certificate for the year 2006-07 will be submitted while releasing the 2<sup>nd</sup> installment for the financial year 2007-08.**

2. All other terms and conditions for release of funds for the Project will remain unchanged.
3. The expenditure involved is debitable to the Major Head "2230" Labour and Employment 01 Labour 01.113 Improvement in Working Condition of Child/Women Labour –02 - Child Labour Cell -02.03 - National Child Labour Projects - 02.03.31- Grants-in-aid for the year **2007-08(PLAN)**.
4. The grant-in-aid will be released in accordance with procedure laid down in the Ministry of Finance, Department of Economic Affairs Office Memorandum No. 10(48)-B/68 dated 25<sup>th</sup> November, 1969. The Section Officer (Cash Section)/Drawing and Disbursing Officer, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para 1 above for **Rs. 10,62,992/- (Rs. Ten Lakh Sixty Two Thousand Nine Hundred & Ninety Two Only)** and remit the same to **the District Collector & Chairman, Child Labour Project Society, Tiruchirapalli District, Tamil Nadu** through crossed demand draft under intimation to Child Labour Section.
5. The sanction issues in consultation with Internal Finance Division vide its **Dy. No.1088** dated **16.8.07**.
