CIRCULAR

Subject: Submission of Annual Immovable Property Returns for the years 2010 and 2011 by Group A and B (Gazetted and Non-gazetted) Officers of Ministry of Labour and Employment - regarding.

The undersigned is directed to say that Annual Immovable Property Return for the year 2010 (as on 1.1.2011) was to be furnished by all Group A & Group B (Gazetted and Non-gazetted) officers latest by 31st January, 2011. It has been noticed that a large number of officers (of CLS Cadre) have not furnished their AIPR, 2010 till date. The non-submission of AIPRs by the concerned officers has been viewed seriously by Secretary (L&E) in a meeting to review vigilance matters of Ministry of Labour and Employment. All defaulting officers are hereby directed through their Cadre Controlling authorities to furnish their AIPR 2010 without further delay.

2. The AIPR for the year 2011 has become due on 1.1.2012. All Group A & Group B (Gazetted and Non-gazetted) officers have to deposit their AIPR 2011 by January 31, 2012.

3. Vigilance Section has been denying Vigilance Clearance to officers defaulting in submission of AIPRs. It has been decided with the approval of Secretary (L&E) that starting from the AIPR 2011 (which has become due on 1.1.2012), necessary disciplinary action under CCS (Conduct) Rules will be initiated besides denying Vigilance Clearance to those officers who default in submission of their Annual Immovable Property Returns within the prescribed time.

4. All the cadre controlling authorities under Ministry of Labour & Employment are further reminded that the scanned copies of the AIPRs and the List of officers defaulting in submission of their AIPRs should be posted on the website of this Ministry/their respective websites, in time.
