Subject: Reimbursement of Raw Material in Government ITI in the State of MANIPUR under the Centrally Sponsored Scheme of "Establishment of Industrial Training Institutes (ITI s) in the North Eastern States and Sikkim"- Release of central share for purchase of Raw Material.

Sir,

I am directed to convey sanction of the President to incur an expenditure not exceeding Rs. 73,53,000/- (Rupees Seventy Three Lakh and Fifty Three Thousand only) for procurement of raw material for the existing ITI and establishment of new ITIs under the scheme "Establishment of Industrial Training Institutes (ITI s) in North-Eastern States and Sikkim" for the State of Manipur during the Financial Year 2006-2007.

I am also directed to convey the sanction of the President for release of 80% of the sanctioned amount equivalent to Rs. 58,82,000/- (Rupees Fifty Eight Lakh and Eighty Two Thousand only) to the State Government of Manipur for the raw materials for which order has been placed by the State Government for their existing and new ITIs as per the approved norms of NCVT/ DGE&T.

1. The release of Central fund of Rs. 58,82,000/- (Rupees Fifty Eight Lakh and Eighty Two Thousand only) for raw material in respect of the said scheme is subject to the following conditions :
 - (i) The Raw Material purchased should be strictly in accordance with the standard list, as prescribed by NCVT for the particular trade or as per the list prescribed under "Project 150" of CSTARI, Kolkata for short-Term Courses under the approved scheme.
 - (ii) The grant shall be utilized only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
 - (iii) The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
 - (iv) The Utilization Certificate in Form GFR 19-A indicating component-wise expenditure under the scheme should be furnished to the Directorate General in Duplicate.

- (v) After making purchases, bid documents, bids, evaluation report and Letter of Award should be retained by the State Directorate for post-award review by DGE&T, CPIU.
2. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.

3. The expenditure is debitible to the following Head of Account :


