1. The release of Central fund of **Rs. 5,64,255/- (Rupees Five lac sixty four thousand two hundred and fifty five only)** in respect of the said scheme is subject to the following conditions :

(i) The reimbursement of salary should be strictly in conformity with the approved posts as conveyed to you in respect to your institute vide letter No. DGET-2(1)-2000-03-CPIU/NES-Arunachal Pradesh dated 10<sup>th</sup> July 2003.

(ii) The grant shall be utilized only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.

- (iii) The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
- (iv) The Utilization Certificate in Form GFR 19-A indicating component-wise expenditure under the scheme should be furnished to the Directorate General in Duplicate for claiming further releases on recurring expenditure.
2. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
3. The expenditure is debitable to Major Head "3601" – Grants-in-Aid to State Governments and under Minor Head 04.321.03.02.31 – Establishment of New ITIs in North Eastern States and Sikkim and will be met out of the budget grant of FY 2006--2007.
