Madam,

I am directed to refer to this Ministry's letters of even number dated 6th February, 2007 regarding the above subject and to the **Commissioner of Labour, Government of Tamilnadu, Chennai's** letter No. M4/306/0/2008 dated 16th September, 2008, enclosed along with a report signed by the Collector & Chairman, District Rural Development Agency, Tirunelveli, recommending release of 2nd instalment of subsidy for **257 (out of 559)** beneficiaries, and to convey the approval of the Competent Authority for the release of 2nd instalment of subsidy @ Rs. 20,000/- houses, amounting Rs.32, 40,000/- (Rupees Thirty Two Lakh And Forty Thousand Only), after adjusting unspent 1st instalment of subsidy, amounting Rs. 19.00 Lakh released earlier vide sanction letter of even number dated 06.02.07 in respect of 95 beedi workers, who have not started construction, from out of Rs. 51.40 Lakh for 257 houses. Payable to the **Chief Secretary to the Government of Tamilnadu, Chennai** under the Revised Integrated Housing Scheme, 2005 (RIHS, 2005), circulated vide this Ministry's letter No. M-11011/01/2005-W.III dated 27th May, 2005 as amended vide letter dated 27.04.07.

2. The above approval is subject to the condition that the 2nd instalment of subsidy of **Rs.32.40 Lakh**, so released by the Ministry would, in turn, be released to the concerned beneficiaries, along with unspent subsidy of Rs. 19.00 Lakh kept with the State Government by the **Tamilnadu Government**, & would ensure that terms & conditions under RIHS and Ministry's sanction letter of even number dated 06.02.07 are adhered to. The expenditure would be debitable to Major Head -2230 01.109.Beedi Workers Welfare Fund 01.109.01 - Housing 01.109.06 - Revised Integrated Housing Scheme - 2005 06.00.33 - Subsidies from the budget grants during the financial year 2008-09.
