Subject: Release of central funds to meet the expenditure on review meeting to the State of Assam under Centrally Sponsored Scheme "Externally aided Project for Reforms and Improvement in Vocational Training Services rendered by the Central and the State Governments" – Vocational Training Improvement Project with World Bank assistance.

Sir,

I am directed to convey the sanction of the President for release of central funds of Rs. 4,95,518/- (Rupees Four Lakh, Ninety Five Thousand, Five Hundred Only) to meet the expenditure incurred by the State Government of Assam on the review meeting held at Guwahati on 29th & 30th May 2008, under Centrally Sponsored Scheme "Externally aided Project for Reforms and Improvement in Vocational Training Services rendered by the Central and the State Governments" – Vocational Training Improvement Project with World Bank assistance.

2. The release of central fund of Rs. 4, 95,518/- (Rupees Four Lakh, Ninety Five Thousand, Five Hundred Only) in respect of the said scheme, is subject to the following conditions: *Eighteen*
 - (i) The grant is utilized only for the purpose for which it has been sanctioned and approved norms as applicable under World Bank procurement procedure are followed. No portion of the grant should be spent on any other item and any amount not spent should be surrendered to the Central Government.
 - (ii) The Utilization Certificate in Form GFR 19-A indicating details of expenditure under the scheme should be furnished to the Directorate General in Duplicate.
3. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
4. The expenditure is debit to the Major Head "3601" during FY 2008-2009:
