Madam,

The undersigned is directed to refer to above mentioned administrative approval in which 1st instalment of subsidy was released to the Maharashtra Government for the construction of houses by the beedi workers in Gondia District in Maharashtra in respect of approval detailed (i) and (ii) in the references made above; and on the basis of Status Report received from the Asstt. Labour Commissioner Gondia vide its letter ALC/Gondia/BKGY/AS/2579 to 2583 dated 28-11-2008, through Welfare Commissioner, Nagpur, I am to convey the sanction of the President of India for the release of 2nd instalment of 50% subsidy for construction of 13 houses @ Rs. 20,000/- per beneficiaries amounting to Rs. 2,60,000/- (Rs. Two Lakhs and Sixty thousand only) payable to the Chief Secretary to the State Government of Maharashtra under the Revised Integrated Housing Scheme (RIHS) 2005 circulated vide this Ministry's letter No. M-11011/01/2005-W.III dated 27th May, 2005 as amended vide letter dated 27-04-2007 and as per list of beneficiaries enclosed with the sanction letter.

2. The above approval is subject to the condition that the amount of subsidy would be released to the Assistant Commissioner of Labour, State Government of Maharashtra, Gondia, which, in turn, would be released to the District Collector Gondia District, Maharashtra by the State Government, as per provisions of RIHS, 2005 as amended vide letter dated 27-04-2007. The expenditure would be debitable to Major Head -2230 01.109.Beedi Workers Welfare Fund 01.109.01 - Housing 01.109.06 - Revised Integrated Housing Scheme - 2005 06.00.33 - Subsidies from the budget grants during the financial year 2008-09.

3. This issues with the approval of DGLW in terms of powers delegated to him under Para 3(ii) & (iii) of RIHS-2007 Scheme vide Letter No. M-11011/1/05 - W-III, dated 27th April, 2007.
