I am directed to convey the sanction of the President of India for the release of central funds of **Rs. 4,03,847/- (Rupees Four Lakh Three Thousand Eight Hundred and Forty Seven Only)** to meet the expenditure incurred by the State Government of **Rajasthan** for organizing the Joint Review Mission(JRM) meeting from 08th to 12th September '08, under Centrally Sponsored Scheme "Externally aided Project for Reforms and Improvement in Vocational Training Services rendered by the Central and the State Governments" - Vocational Training Improvement Project with World Bank assistance.
