Madam,

In continuation to this Ministry's letter of even number dated 23<sup>rd</sup> December, 2008 the undersigned is directed to refer to this Ministry's sanction letter No. M-11015/35/06-W.III dt. 12.02.07 in which 1<sup>st</sup> instalment of subsidy was released to the Uttar Pradesh Government for construction of 16 houses by beedi workers in Amroha; and on the basis of Inspection Report received from the District Magistrate, Jyotiba Phule Nagar (Amroha) vide its letter No. 1273-76 dated 15-12-2008, I am to convey the sanction of the President of India for the release of 2<sup>nd</sup> instalment of subsidy of Rs. 20,000 (Rupees Twenty Thousand Only) to the Chief Secretary, Uttar Pradesh Government, Lucknow for one (out of 16) house of Shri Ahmad Hasan S/o Shri Alla Mehar; on reaching the construction at Roof Level or above.

2. The expenditure would be debit to Major Head -2230.01.109. Beedi Workers Welfare Fund 01.109.01-Housing 01.109.06- Revised Integrated Housing Scheme-2005 06.00.33 - Subsidies from the budget grants during the financial year 2008-09.

3. This issues with the approval of Director General (Labour & Employment) under powers delegated to him in Para No. 3 (ii) under the Revised Integrated Housing Scheme, 2007 dated 27.04.2007.


