Subject: Sanction of **third (final) installment** for Civil Works in ITI **Gandhinagar, Gujarat** under the Centrally Sponsored Scheme (CSS) of "Upgradation of training infrastructure in 100 Government ITIs".

Sir,

This sanction is in continuation to this Directorate General letter of even no. dated 30-3-2006 wherein sanction was accorded for **Rs. 27.38 lakhs** as Central Share for the construction/ renovation work in **ITI Gandhinagar, Gujarat** under the Centrally Sponsored Scheme (CSS) of 'Upgradation of training infrastructure in 100 Govt. ITIs' and subsequently **Rs. 6.84 Lakh & Rs. 13.70 lakh** were released as **first & second installment** respectively to the State Government of **Gujarat** vide letter of even no. dated 30-3-2006 & 13-3-2007 respectively.

I am now directed to convey the sanction of the President of India for release of balance 25% of the Central Share amounting to **Rs. 6.84 lakhs (Rupees Six Lakh and Eighty Four Thousand only)** as third (final) installment to the State Government of **Gujarat** for the construction/ renovation work in ITI.

2. The release of Central fund of **Rs. 6.84 lakhs** to the State Government of **Gujarat** in respect of the said scheme is subject to the following conditions:

- The ITIs should be renovated or constructed in accordance with the NCVT approved space norms and estimates prepared by PWD or State approved agency.
- The grant shall be utilized keeping in view the guidelines of the Scheme/ MoU and only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
- The grant should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.
- IMC clearance must be obtained before initiating bidding/tendering for civil works.
- The work shall be awarded after open competition / bidding / tendering through PWD / State approved agency.
- The Utilisation Certificate in Form GFR 19-A in respect of individual ITI indicating expenditure under the scheme should be furnished to the DGE&T in Duplicate.

3. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.
